Dear Realtor® MLS Participant Weix,

In a recent RAMC audit of the Multiple Listing Service (MLS), it was discovered there are offices within the territorial jurisdiction of RAMC that are out of compliance with the MLS Rules and Regulations. As defined in the bylaws, the territorial jurisdiction of the Realtor® Association of Martin County is all of Martin County lying North of Bridge Road, West to County Line and East to the Atlantic Ocean.

Our goal is to assist those offices in becoming compliant so as to protect the integrity of the rules and of the Multiple Listing Service itself. Some of the offices determined out of compliance were small, some were mid-size and some were large firms. Overall, it is a very small percentage of those participating in the MLS as a whole, so we are confident we will be able to bring everyone into compliance in a relatively short period of time.

The MLS Rules and Regulations, Section 6 (b) states:

(b) Recurring Participation Fee: Each Participant and Subscriber [salesperson] and licensed or certified appraiser who has access to and use of the Service, whether licensed as a broker, sales licensee, or licensed or certified appraiser who is employed by or affiliated as an independent contractor with a Participant shall pay in advance to the Association Office, the fee established by the Board of Directors. Ultimate responsibility for Subscriber's recurring participation fee is the responsibility of the Participant.

In other words, when the Participant elects to participate in the RAMC MLS, and their office's physical location lies within the territorial jurisdiction of RAMC, then <u>all</u> of their licensed salespersons must also participate as Subscribers and pay the recurring participation fee and abide by the MLS Rules and Regulations.

**Diane Mosley, Director of NAR's policy department explains:** The fact that some licensees do not use the system isn't determinative of whether all licensees may be charged, it is the fact that they can use the service given their affiliation with the Participant.

Diane further explains that in addition to Section 6, the latter half of Policy Statement 7.42 found on page 10 of the *Handbook on Multiple Listing Policy* makes it clear that if a firm has multiple offices within the jurisdiction of the MLS, the MLS can charge all the offices.

You are receiving this letter because one or more of your offices has been identified as non-compliant with the MLS Rules and Regulations. In an effort to assist you in becoming compliant, attached is a list of all sales licensees affiliated with you as the Participant, and highlighted, are those licensees who are not paying the Subscriber recurring participation fee.

In an effort to resolve this issue in a timely manner, the Board of Directors has voted that all MLS Participants shall be in compliance no later than July 1, 2016. And in an effort to assist those sales licensees who are not in compliance at this time, the fee to become an MLS Subscriber will be the July pro-rated fee of \$224.25. Also attached, for your convenience, is a RAMC MLS Subscriber Application. The application must be completed by each new Subscriber so their information can be entered correctly into the MLS.

MLS Subscriber Applications and payment can be mailed or dropped off to the association office. They can also be e-mailed to <a href="maileometriship@ramcfl.org">membership@ramcfl.org</a> and upon receipt we will contact the applicant for their credit card information.

Effective August 1, 2016, offices who are not in compliance with the MLS Rules and Regulations may be suspended from the MLS for failure to pay service charges. A Board MLS is not obligated to provide MLS services, including continued inclusion of the suspended Participant's listings in the MLS compilation of current listing information.

We appreciate your cooperation and willingness to comply with the MLS Rules and Regulations in a timely manner. Compliance ensures the integrity of our Multiple Listing Service.


